5.0 Guest Speaker:

5.1 Alex Byers Glasgow Life: Update regarding summer holiday activity programme

Reassurances were given to the community council that Glasgow Life were looking to work in partnership with North United Communities and other partners in the area, to deliver a summer holiday programme. This is to avoid duplication and have activities available to young people so no one misses out. In the past Glasgow Life's activities has conflicted with North United Communities. Alex highlighted that this is the very reason that Glasgow Life are looking for a joined up way of working. Glasgow City Council is a Co-Operative Council and wants to change the way they do things, working locally with organisations, looking at what's best for the community looking at what's already out there. Glasgow Life is willing to put all resources on the table eg staff, buildings etc to create a joint programme. After summer look at what has been learn/achieved once programme has been delivered. 9.0 A.O.C.B.

- 9.1 Maryhill Housing Association applied to stalled spaces for the Ruchill Allotment site and was successful in their application. They have been awarded £2500 for some materials and gardening equipment.
- 9.2 Concerns were raised about the allocation of some of Maryhill Housing Associations properties. Dawn advised each applicant's situation and points vary and individual applications can't be discussed. Dawn recommended that the chairperson contacts Jennifer Simon who is the Housing Services manager to discuss the specific cases referred to. Tenant Scrutiny Panel is currently looking at the allocation policy which is likely to be changed due to changes in the law.
- 9.3 Issues were raised about lack of privacy/security at the reception area in MHA offices with tenants being asked to provide ID such as passports and bank statements. It was felt that this was inappropriate and customers should be taken into both when this information is being requested. Dawn will feed this back.
- 9.4 It was agreed that Eleanor Brown would write to Maryhill Housing Association requesting that the post of Customer Engagement Officer is made permanent.
