- 4.2 Police Scotland is reviewing their estate at the moment as the last time this was reviewed was in the 60/70s. The Police Station in Possilpark is closing. At the moment only civilians work there; it is not a frontline station and footfall is low. Staff will be accommodated elsewhere in Glasgow either Baird Street or Maryhill Police Station. Residents were not happy that there would be a lack of Police presence in the area and although it's not officers who are based there, just having a presence would act as a deterrent and makes people feel safer. - Stephen echoed these sentiments. Officers will pass these concerns back to their sergeant.
- 4.3 Residents were encouraged to report any concerns, unusual or suspicious behaviour in Curzon Street to Police Scotland or Crimestoppers.
- 4.4 Eleanor mentioned that she had received a letter from the Health Lottery UK stating she was a winner and had to pay £1200 release £300k. EB didn't want others to fall victim to this scam. Officers will log on the system and update EB of outcome.

#### 6.0 Guest Speaker

#### **6.1 Councillor Helen Stephen**

Cllr Stephen advised that she had highlighted her concerns over the closure of the police station in Possilpark. Whilst understanding this was due to budget constraints she was concerned over the time and cost for residents to travel to Baird Street or Maryhill and was disappointed to be losing another community asset.

GCC are setting their budget. This was £130 million over the last two years but the Scottish Government has set another target of £20 million over 2017/18. GCC has increased council tax for bands E to G by 7% and band H by 22%

Eleanor requested assistance with obtaining lease from City Property and noted that it was disappointing that the units at Chapel Street were still empty and have been for the last 7 months. If GCC are cutting budgets they should improve the letting process to avoid loss of rental income. Cllr Stephen will speak with City Property again – the last time she spoke to someone from CP Helen was advised that their solicitors were dealing with it.

Alasdair Smith was in attendance. He is a local resident who is standing for election for the Green Party and wanted to meet residents and hear about local matters. The Green Party organised a walk from Maryhill to Springburn Job Centre to calculate the distance and how long it takes. It took 1hour and 2 minutes and was over 3 miles. DWP has been criticised that consultation should be better
