i. Chair highlighted the recent paper from Glasgow City Council in relation to Ruchill Community Centre and possible steps to full closure.

Discussions were held on this and it was decided to gather information from the Ruchill Action Group and approach councilors on the CAC requesting the following;

- a. Delay the proposed date of full closure due to the inaccurate information shared on the proposal.
- b. Ask for the Ruchill Action group to be given the facility and the allocated funding to support them regenerating Ruchill Community Centre.
- c. Re-emphasise the need for fit for purpose community facilities in Ruchill as there are no facilities to hold large events or public meetings for the community.
- d. Possible Judicial process due to process being unequal Open gates Charity where offered the space without following the PMGC process and this was seen as unfair.

Theresa Ryan suggested group should have a conversation with the NUC. Brian Land to contact Jill Mackay.

ii. Ann McGinley informed the meeting that the notice board has been paid and will be erected within the next 15-20 days – a slight cost increase of £200 was paid.

iii. Fran Lundie from Glasgow City Council confirmed the Notice Board will be erected. Community highlighted some issues including overgrown bushes and trees on Brassey Street which were already reported in November 2024. Pot holes on Bilsland Drive and Brassey Street.
